Blues and Ameren Missouri present Power Play Goals for Kids

If you have attended a Blues game or watched on TV, people get pumped up for the Ameren Missouri Power Play. Obviously, they are hoping for a power play goal but did you know that for each power play goal \$500 will go to a local children's charity.

We realize that engineers need PDH's and contractors need contact hours for Jefferson County's and City of St. Louis' continuing education for license renewal.
