Booth Selection Process

- **Reserve early!** Only 190 booths inside exhibit hall are available.
- **Early selection window:** August 1 – October 31, 2025
 - Priority is based on:
 1. Number of booths requested
 2. Date contract and payment are received
 3. Past exhibitor status
- Exhibitors who qualify will be contacted in late November to choose from available booths.
- **Full payment must be received by October 31** to qualify for early selection.
- After that, booths will be assigned on a first-come, first-served basis (if paid).
